ANNUAL REPORT 2016-2017



Girls in STEM was founded in 2014 with the purpose of increasing the number of women entering the workforce in a STEM profession. Starting with 8 high school girls, in just three short years we have grown our program to 101 members and have reached an additional 102 girls in the metro Denver area through our community partnerships and collaborative events.

Each amazing girl we meet is different, from where they live and go to school, to their ethnicity. Each girl has her own story and idea of what her place in the world will look like. Some girls have already decided what they want to be when they grow up, while others are passively gravitating towards what they think they have to be. Girls in STEM strives to introduce ALL girls to inspiring women working in STEM fields to help them understand the possibility and attainability of a career in science, technology, engineering, and math. And, just as important, Girls in STEM works to help girls understand why women are an essential part of the workforce equation.

With only 26% of STEM jobs being held by women (and even smaller percentages when looking closer at engineering and technology fields), we believe it is necessary to encourage girls to seek a STEM career post-secondary education.

With your support, we will continue to empower the next generation of girls to visualize themselves in a STEM career and to understand the value they add to the workforce.






Expenses by category
